To our customers

This letter comes to inform you of the current implementation status of REACH in our company.

Registration: According to Annex V, Article 11 of REACH, quartzglass, like all glass, is exempted from mandatory registration.

Our quartzglass is likewise free of dangerous substances as defined in the regulation (Article 59(1) and (10), SVHC candidate list, Annex XIV).

Information communication requirements: Our requirements as a manufacturer are defined in the regulation under Title IV, Articles 31– 36, "Information in the Supply Chain" and in Title V, Articles 37–39, "Downstream Users".

We hereby confirm that we recognize these requirements and are aware of our legal responsibility to meet them. Our company will undertake all necessary measures to this end.

Since our products are made of quartzglass, and since glass materials are not included in the candidate list, our products have no formal reporting requirement.

Regardless of this, we are always available to respond to your queries about our quartzglass.

Supply security: We are in close contact with our suppliers to ensure that all raw materials and resources needed to produce quartzglass conform to REACH regulations.

Based on current feedback from our suppliers, we can safely assume that all materials required to produce our products will continue to be available in the future, unlimited and unaffected by REACH considerations.
